APPENDIX I

<u>Guidelines for Erection/Installation of Billboards within the City Limits of Majlis Bandaraya</u> Kuching Selatan.

A. Sites and Places Not Suitable for Billboards

- 1. Places where erection of billboards will interfere with water pipelines, SESCO and Telecommunication service lines and facilities;
- 2. In traffic roundabouts, central dividers and traffic islands at road junctions.

B. Content of Advertisement

- 1. An advertisement may be made or exhibited in any language.
- 2. Words and letters in Bahasa Malaysia when used together with any other language must be given prominence in terms of size and colour, and in more outstanding place than words or characters in the other language used.
- 3. To ensure correct usage of Bahasa Malaysia in any advertisement, the Local Authority may refer the words used (in Bahasa Malaysia) to Dewan Bahasa dan Pustaka for its advice and confirmation before any such advertisement can be exhibited or displayed to the public.
- 4. Advertisements on tobacco products and liquor are prohibited.
- 5. All advertisements must not be offensive in nature (e.g no slander and obscene advertisement).

C. Advertisement License Fee

1. The rate or the license fee shall be as follows:-

(a) For the first 20 square metre or part thereof meter per year
 (b) For every additional square metre or part RM70.00 per year

thereof

Annual Rental (For erection of billboards on land vested to Council)

Range from RM37,500.00

to RM105,000.00

Refundable deposit RM5,000.00

D. Technical Requirements and Conditions for the Erection of the Billboards

- In accordance to Building By-laws 16, plans or sketch plans showing the full details of the advertisement and the site proposed shall be submitted for Council's consideration and approval. Structured plans for the billboard shall be certified by a qualified engineer registered with the Board of Engineers Malaysia;
- 2. All electrical wiring and lighting installation shall be certified by a registered electrical engineer;
- 3. A separate SESCO meter shall be installed for the above purpose, and all the monthly electricity bills shall be borne by the advertiser;
- 4. The billboard shall be erected at least 2 metres from the ground level and the space shall be left free;
- 5. Public liability insurance with a minimum coverage of one hundred thousand ringgit or one million ringgit shall be taken by the advertiser during the validity of the license. Majlis Bandaraya Kuching Selatan shall not be held responsible for any accident or mishap that occurred arising from the erection of such advertisement billboard;
- 6. License number issued by the Council must be written on the lower right hand corner of the billboard, and must be clear and visible;
- 7. The advertiser is required to maintain the advertisement billboard in a clean, stable and firm condition, and all the electrical lightings/apparatus shall be functioning during the validity period of the permit;
- 8. The surrounding area up to 3 metres from the billboard shall be kept clean and tidy at all times;
- 9. When the period for the display of the advertisement has expired, and has not been extended, the advertisement billboards including the structures shall be removed and cleared from the site within fourteen (14) days from the date of the expiry of the license;
- 10. The Council shall have the liberty to utilise the deposit sum for carrying out the necessary work in the event that the advertiser fails to comply with Council's requirements. If the work executed exceeds the amount of the deposit, the Council reserves the right to recover the balance (less the deposit) from the advertiser.
- 11. In the event of breach of any of the conditions specified above, the Council reserves the right to terminate the license before the expiry thereof by giving one (1) month or three (3) months prior notice in writing to the license holder without assigning any reason thereto.
- 12. The applicant is advice to purchase public liability insurance with a minimum coverage of:

Advertisement displayed location within

- (a) a private compound & not accessible by RM100,000.00 per annum the general public
- (b) Advertisement displayed location is accessible by general public RM1,000,000.00 per annum
