- 2. The participation form shall be filled using **Bahasa Malaysia or English only**. However, the program as per Appendix B **may be filled in other language** such as **Name of Song and Author and/or Singer**.
- 3. **All completed form** shall be submitted to **MBKS One Stop Service Counter No. 9 on or before 4.00 p.m. on 31 March 2026 (Tuesday)**.
- 4. Please be reminded that only completed application form received on or before the closing date will be considered for the forth coming Kuching Festival Fair – Nightly Entertainment, **Subject to availability of slot, creativity, uniqueness and artistry** of the **proposed program submitted**.
- 5. The Kuching Festival Fair – Nightly Entertainment Organizing Committee (Organizing Committee) and/or Council **reserves the right to approve, alter or disapprove any application received** without any further **explanation**. **Only performances, etc approved** by the Organizing Committee and/or Council are allowed to be performed at the MBKS Theatre.
- 6. The Organizing Committee and/or Council **reserve the right to cancel performance without assigning any reason at any time and/or to reduce the duration of the performance**.
- 7. **Performance/Song/Sketch/Film, etc** having **a racial, religious, obscene substance/act/performance, political slant or which have been prohibited by the Government is strictly not allowed**. **The Association/Society, etc shall comply with these prohibitions and shall be responsible for their performance**.
- 8. **Performance using the flammable items, grains, fine paper, etc** on the stage during performance **is not allowed unless approved by the Organizing Committee and/or Council**.
- 9. The **performance shall not extend beyond the time allocated** by the Organizing Committee and/or Council.
- 10. The Organizing Committee and/or Council **shall not be liable for any loss, claim, damage, injury or inconvenience arising out of the activity/performance throughout the Kuching Festival Fair – Nightly Entertainment period**.
