THE KUCHING MUNICIPAL ORDINANCE

THE CITY OF KUCHING SOUTH
(MARKETS) (AMENDMENT) BY-LAWS, 1997

(Made under section 100)

In exercise of the powers conferred by section 100 of the Kuching Municipal Ordinance as modified by section 4(1) of the City of Kuching Ordinance, 1988, to apply to the City of Kuching South, the Council of the City of Kuching South has, in compliance with the provisions of Part XI of the Kuching Municipal Ordinance and with the approval of the Minister, made the following By-laws:

1.—(1) These By-laws may be cited as the **City of Kuching South (Markets) (Amendment) By-laws, 1997**, and shall come into force on such date as the Council may, by notification in the *Gazette*, appoint.

Citation, commencement and application.

(2) These By-law shall apply only to the area of the City of Kuching South.

2. By-laws 2 of the Kuching Municipal Council (Markets) By-laws is amended by inserting immediately before the definition of "goods" the following new definitions:

"chekor" means local indigenous food items;

"Council" means the Council of the City of Kuching South".

3. By-law 27 of the Principal By-laws is amended—

Amendment of by-law 27.

(a) by substituting for the words "one hundred dollars" in the fifth line the words "one thousand ringgit"; and

(b) by substituting for the words "ten dollars" in the penultimate line the words "one hundred ringgit".

4. There shall be substituted for the Schedule to the Principal By-law the following new Schedule:
