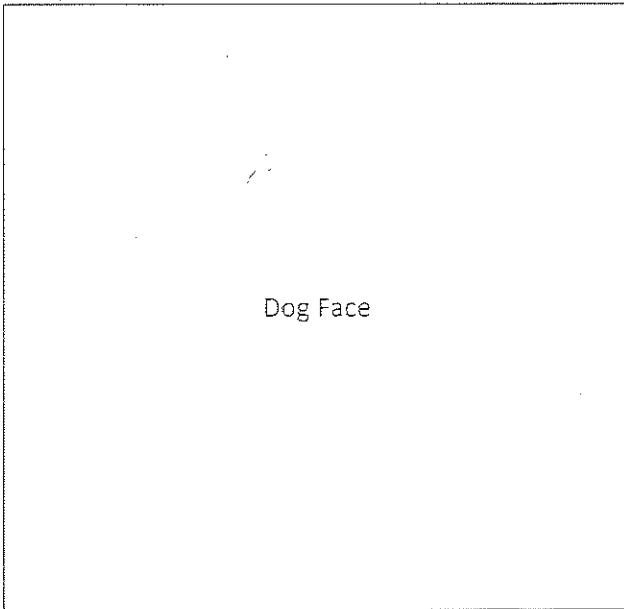

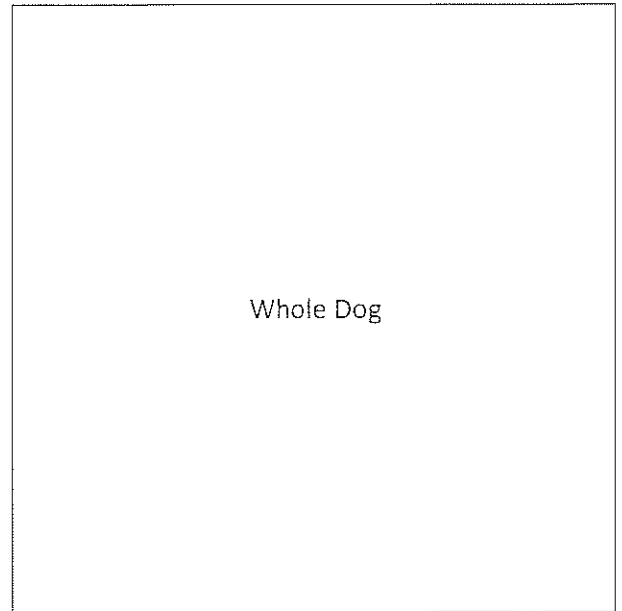

**Keperluan Minimum untuk Permohonan Lesen Anjing**  
**(Minimum Requirements for Dog Licence Application)**

**1. Pemohon (Applicant)**

1.1 Persendirian (*Individual*)

1.1.1 Umur 18 tahun keatas. (*18 years old and above*)

1.1.2 Warga Sarawak. (*Sarawakian*)

1.1.3 Jika bukan Warga Sarawak, Permit Kerja / Passport diperlukan.  
(*For Non-Sarawakian, Work Permit / Passport is required.*)

1.2 Korporat / Firma / Persatuan dsb. (*Corporation / Firm / Society, etc*)

1.2.1 Korporat / Firma / Persatuan mestilah berdaftar dengan Lembaga hasil Dalam Negara (LHDN) / Suruhanjaya Syarikat Malaysia (SSM) / Pejabat Kewangan / Pejabat Daerah / Jabatan Pendaftaran Pertubuhan dsb.  
(*Corporation / Firm etc must be registered with Inland Revenue Board (LHDN) / Malaysia Companies Commission (SSM) / Treasury Office / District Office / Registrar of Society, etc*)

1.2.2 Mempunyai Lesen / Pendaftaran Perniagaan yang sah.  
(*Possess a valid trade licence / registration*)

1.2.3 Menamakan wakil kepada Korporat / Firma / Persatuan dsb.  
(*Nominate a nominee to represent the Corporation / Firm / Society, etc*)

2.1 Maksimum 3 ekor anjing bagi setiap harta tanah.  
(*Maximum 3 dogs for each landed property*)

2.2 Tiada sesiapa dibenarkan untuk memelihara lebih daripada satu ekor anjing jenis baka kecil di flat, rumah pangsa dan kondominium.  
(*No person shall keep more than one small breed dog at flat, apartment & condominium*)

2.3 Mendapat Kelulusan Malaysian Quarantine & Inspection Services Department (MAQIS) untuk baka anjing terhad. Sila rujuk Lampiran A.  
(*Malaysian Quarantine & Inspection Services Department (MAQIS) approval is required for restricted dog breed as per Appendix A*)

**3. Keperluan Lokasi (Siting Requirement)**

Tiada sesiapa dibenarkan memelihara lebih daripada satu ekor anjing jenis baka kecil di flat, rumah pangsa dan kondominium. Kebenaran daripada pihak Pengurusan adalah diperlukan.

(*No person shall keep more than one small breed dog at flat, apartment & condominium. In addition, Management Corporation consent is required*)
